The 2019 Grades 3-8 New York State Assessments: What Parents Need to Know

Every spring, the Grades 3-8 English Language Arts (ELA) and Mathematics Tests are administered to students across New York State. These annual ELA and math tests for students in grades 3-8 are required by the federal Every Student Succeeds Act (ESSA) of 2015. The tests are designed to measure how well students are mastering the learning standards that guide classroom instruction and help to ensure that students are on track to graduate from high school with the critical thinking, problem solving, and reasoning skills needed for success in college and the modern workplace. The tests also show how schools and districts are progressing with the learning standards and can support professional development for teachers. Below you will find information about the 2019 tests.

Fewer Test Sessions

- Like the 2018 tests, the 2019 Grades 3-8 ELA and Math Tests are two sessions each.
- With fewer test sessions, each test will have substantially fewer questions than in recent years, lessening test fatigue for students and better enabling them to demonstrate what they know and are able to do.

Untimed Tests

- Like the 2016 2018 tests, the 2019 Grades 3-8 ELA and Math Tests will be untimed.
- In general, this means that as long as students are working productively, they will have as much time as they need to complete each test session, within the confines of the regular school day.
- Schools and districts have discretion to allow students to read silently or quietly exit the room when they have completed their test while others continue to work.

Test Questions Reviewed and Written by New York State Teachers

- Teachers from across the State serve on committees to write, evaluate and select questions for the tests.
- Hundreds of New York State educators were involved in creating and reviewing questions for 2019 Grades 3-8 ELA and Math Tests and selecting the questions for the test forms.
- This year, most of the test questions were written by New York State teachers specifically for the annual New York State tests.

Providing Results for Teachers and Improved Resources for Parents

- Like the previous three years, the New York State Education Department plans to have instructional reports returned to teachers by the end of the school year and to release at least 75% of the test questions again.
- The 2019 Score Reports for parents will feature more information about what students should know and be able to do at each grade level.

Computer-Based Testing

- Some schools chose to administer the 2019 Grades 3-8 ELA and Math Tests on computers rather than by paper and pencil. The computer-based tests (CBT) will have the same questions as the paper versions. Students in those schools utilizing the CBT option have access to CBT practice tests and most have had prior experience participating in other computer-based tests in ELA and Math.
- The long-term plan is for all schools to use CBT for annual State tests. CBT has the potential to further reduce the need for stand-alone field tests and make assessments better instructional tools for students with disabilities.

Creative Commons licensing allows the creators of content on the Internet to specify certain conditions in which their work may be copied and shared without having to go through a formal copyright process. For example: The **BY** acronym and icon indicates that this material requires an attribution specifying who the work was created by. The **NC** indicates it must be noncommercial use, and the **ND** indicates no derivatives the work cannot be modified without permission.

Kathleen A. Morris is a primary school teacher from Geelong, Victoria, Australia. She is a well-known educational blogger who is passionate



about teaching edtech, research skills, global collaboration, and digital citizenship.

WHAT TEACHERS CAN DO ABOUT CYBERBULLYING

NOTE: FIRST AND FOREMOST, IT IS IMPORTANT THAT TEACHERS BE AWARE OF AND FOLLOW ANY BUILDING, DISTRICT, OR BOARD GUIDELINES AND POLICIES FOR REPORTING AND HANDLING INCIDENTS OF ONLINE BULLYING OR HARASSMENT. IF YOUR DISTRICT DOESN'T HAVE THESE POLICIES IN PLACE, GET INVOLVED IN HELPING TO DEVELOP THEM.

While online harassment and bullying doesn't necessarily happen in the classroom, it does have a profound effect on how students may behave toward each other in class. Teachers very often are told of incidents that have happened online, and they have to deal with the aftermath as it affects their classes. What things can teachers do to try to prevent these incidents?

1. Explicitly teach positive online behavior, explain the negative behaviors, and let students know that the negative ones will not be tolerated.

Model the good behaviors and discuss various scenarios that the students may encounter online. Reinforce the positive solutions.

2. Notify parents of what the expectations are for their children.

Keep an open dialogue about these behaviors. Let parents know what to look for, and encourage parents to discuss the positive behaviors with students.

3. Teach kindness and empathy.

Create activities where students can practice being kind to each other. Expect the best in how they treat each other.

4. Remind students that what happens on the Internet is public and it can be permanent.

Social media is often a group experience. Bullying and shaming behaviors often happen in public situations. Once it has occurred, it is often difficult to get the material deleted. Many adults have been embarrassed by things that occurred online during their teen years.

5. Use appropriate resources from outside your classroom.

There are many good sources of videos that promote positive online behaviors. Find some, view, and discuss them with your students. Or even better, create your own videos with your students, and share them with other classes.

I WILL GIVE CREDIT TO OTHERS FOR THEIR WORK

You may use images from the Internet for school projects or presentations - but do you know that **you might be breaking copyright laws**?

If an image isn't something that you created the odds are that someone else owns the copyright and that means that you may need to get their permission before using it. Even if you are able to get permission you still may need to give credit to the original owner or creator of the image.

HOW CAN I MAKE SURE THAT I HAVE THE RIGHT TO USE AN IMAGE?

- 1. Get permission from the image creator or the copyright owner. It may be difficult to locate and obtain the permission from the proper person.
- 2. Create the image yourself. Use software programs that allow you make images like MS Paint, Google Drawings, Autodraw (<u>autodraw.com</u>), Canva (<u>canva.com</u>), or Adobe Spark (<u>spark.adobe.com</u>). Or use your phone or a digital camera to take a digital photo. Photos of objects, and public events (as long as specific people are not recognizable) don't require special permission. You may need a photo release if people can be recognized in your image.
- 3. Search for images that are licensed for your use. Learn about Creative Commons licensing that artists can use to give other permission to use their work without having to ask for permission. There are also sites that have images that are royalty-free. Google image search tools let you specify "Usage rights" as a parameter.

Creative Commons licensing uses icons to show how an item is licensed. The first icon below shows that the item is in the public domain (free to use) and the second one shows that the item may be used as long as attribution (by) text is included.
