Dear Parents and Guardians,

Happy New Year! I hope this message finds you and your family healthy and ready to embrace a new year. As we move through the new year, please read the following very important reminders.

- Next week begins our winter AIMSWEB benchmarking for all students K-4 in the areas of math and reading.
- There is no school on Monday, January 15th 2024, in honor of Dr. Martin Luther King Day
- There is no school on Monday, January 29th, 2024, as it is a Superintendent's Conference Day.
- Report Cards go home for our K-4 students on Friday, February 2nd, 2024.
- If you are having any technology issues or concerns, please let your child(ren)'s teacher(s) know. We are here to assist and help as much as we can.
- Our morning K-4 parent drop off time begins promptly at 7:40am and we encourage all families to drop off their children no later than 8:00 am. This allows students to eat breakfast and to enjoy some downtime with their classmates, prior to instruction beginning promptly at 8:15am once our tardy bell rings. We ask all parents to please pull up to the stop sign for student drop off, so that we can keep our parent drop offline running effectively and efficiently.
- Our end of the day K-4 dismissal pick up begins at 2:10pm. We ask all parents for end of the day pick up time, to arrive NO earlier than 2:10pm as we are dismissing our Pre-Kindergarten students from 1:50-2:05pm each day. Early K-4 parent arrival throws off our PK student pick-ups.
- Name Tents, please continue to use your family name tents daily as our staff continue to rotate and having your name tent visible to our callers ensures a more efficient and smoother dismissal process. We greatly appreciate your flexibility and understanding.
- As the winter weather begins to make its way to the Southern Tier of New York State, please be sure to continue to send your child(ren) to school with the appropriate winter weather items such as: coat, hat, boots, mittens, snow pants, etc. All students go outside for recess, so please make sure that your child is prepared each day.
- Lastly, please be sure to listen to the local morning news or radio stations for any weather delays or school cancellations due to inclement weather. If you haven't already, please consider signing up for the automated notification via cell phone so that you are immediately notified once Dr. Douglas has made the decision to either delay our start time by 2 hours or to close school for the day.

FRIENDLY REMINDERS:

•Valuable Items in School

Each year over Winter Recess, many of our students will receive gifts that they will treasure. To avoid the possibility of damage or loss of any valuable items, including electronics, we encourage students to leave those items at home. Recess

Students continue to go outside for recess during winter months. Please be sure that your child has a warm coat, hat, gloves/mittens, and boots so they can stay warm as they play. *Please remember that the nurse cannot provide boots for any student.

•Changes in Going Home Routine/Bus Notes

Please remember to write a 'blue note' with your child's change in dismissal plans if he/she will not be following their normal routine. Blue notes should also be written to explain your child's tardiness, absence, or plan to leave early. This is extremely important for the safety of our students.

Lost and Found

Please remind your child(ren) to look in the lost and found bin if they are missing any items that belong to them. There are quite a few articles of clothing in our bin waiting for their owner to reclaim them!



Registration

Big Flats Elementary's Kindergarten registration will be held on Wednesday, January 31, 2024, by appointment only at Big Flats Elementary. If you have a child who will be five vears old on or before December 1st of the school year and whose primary residence is in the Horseheads district, they may be registered for kindergarten. Prior to January 31st, the school will contact you with information on registration and to schedule an appointment. If you are new to the district, or you don't believe the district has your child's information, please call Big Flats Elementary at 607-739-6373. For registration, please bring the required documents. Your child will be screened in speech and hearing later on in the year.

Parents' Bill of Rights Relating to Student Data

The Horseheads Central School District, in compliance with Education Law 2-d, hereby establishes the following Parents' Bill of Rights in regard to student data:

- 1. A student's personally identifiable information will not be sold or released for any commercial purpose;
- 2. Parents have the right to inspect and review the complete contents of their child's educational record. Procedures for reviewing student records can be found in the Board Policy entitled 'Student Records,' Policy 5500, Regulation 5500-R;
- 3. Security protocols regarding confidentiality of personally identifiable information are currently in place and the safeguards necessary to protect the confidentiality of student data are maintained at industry standards and best practices. The safeguards include but are not limited to: encryptions, firewalls, and password protection.
- 4. New York State maintains a complete list of all student data collected by the State and the data is available for public review at www.nysed.gov, or by writing to: 89 Washington Avenue, Albany, NY 12234.
- 5. Parents have the right to have complaints about possible breaches of student data addressed. Complaints should be directed to the Superintendent of Schools, One Raider Lane, Horseheads, NY 14845.

What is the census?

The Horseheads Central School District regularly conducts a district-wide census. This year's census is especially important because the information we receive will assist us in developing elementary school boundary lines as we shift to three elementary schools - Big Flats, Gardner Road, and Ridge Road - at the start of the 2025-26 school year.

Why is Center Street Elementary closing?

After careful consideration of the educational experience of our students and the state of our buildings, the district made the decision to move to three elementary schools. The community supported this plan with the passing of the referendum on December 7, 2021. As one of the oldest buildings in the district, Center Street would require significant construction to upgrade the building to current state standards for an educational space for students. The building is safe for students as it is now, but any additional construction would require asbestos and lead abatement, incurring significant costs that would not be completely covered through state aid. The plan approved by voters includes phasing out Center Street for student use, but keeping the building for district offices and community use.

Which school will my child attend?

The district is working with a demographer to redraw the elementary school attendance boundary lines from four buildings to three. Your response on this census assists the demographer team with redrawing more balanced boundary lines that send students to the school closest to home when possible. A decision regarding the new boundary lines is expected by Summer 2024.



Fight Flu at Home and School

Influenza (flu), spreads easily and can make people very sick, especially kids. You can help stop flu!

Flu symptoms include:

Fever or chills, body aches, cough, sore throat, headache, runny or stuffy nose, feeling very tired. Some people, especially children, may have stomach problems and diarrhea. Unlike a cold, the flu comes on very suddenly.

Prevent flu!

- Flu vaccine is the best protection against the flu. It is recommended every year for everyone 6 months and older.
- Get the flu vaccine for you and your children every year! It helps make flu sickness milder or prevents it altogether.
- Getting the vaccine early in the fall means you and your children will be protected when flu season starts.
- Make sure people close to your children, like babysitters and relatives, are also vaccinated.
- The vaccine is especially important for people with certain medical conditions like asthma, diabetes, and heart or lung disease, because the flu can make them even sicker.

If your child gets the flu:

- · Your child will need plenty of rest and lots of fluids.
- Keep your child home from school for at least 24 hours after their fever is gone without using fever-control medicine. This helps avoid giving the flu to others.
- Talk with your child's health care provider before giving a child any over-the-counter medicine.
- Never give your child or teenager aspirin or any medicine that has aspirin in it. Aspirin can cause serious problems for children and teens.
- Young children and those with certain medical conditions, like asthma, diabetes, and heart or lung disease, are at greater risk for getting seriously ill from the flu.
- If your child gets flu symptoms and is younger than 5 or has a medical condition, call their health care provider and ask about antiviral treatment.
- If you are worried about your child, call their health care provider.

Don't spread flu!

- Wash hands often with soap and water for at least 20 seconds.
- If soap and water aren't handy, use an alcohol-based hand rub.
- Cough or sneeze into a tissue or your elbow, not your hands. Put used tissues in the trash.
- Avoid touching your eyes, nose, and mouth. That's how germs spread.
- Stay away from people who are sick.
