2023-2024 SCHEDULING INFORMATION

All students meet with their school counselor to select courses for the next school year during the spring semester of this school year. This process takes place typically through the months of February through April. During this meeting each student will review their course and exam progress toward graduation, as well as continue work on the student's career plan. Counselors and students discuss the student's future plans and counselors assist them in selecting courses for the following year.

Please note the following:

- These meetings are only to select courses. Schedules are built during the summer months and students will not receive a schedule until the first day of school in September.
- Students cannot request to have specific lunch periods, teachers, or course placement within a schedule.

Each student will have their course selection sheet mailed home after their scheduling meeting so that parents can review their child's selections. Students will have the opportunity to change course selections but please be aware that there are strict deadlines to do so. There will be a course selection change sheet included with the initial mailing. If your student wants to make any changes prior to the last day of school, a change form needs to be returned to the Counseling Office with the requested change indicated and a parent signature. After the last day of school through July 31st students can still make changes using a blue Schedule Change Request form which is available on the High School website and in the Counseling Office. After July 31st no changes to course selections are allowed. If there are conflicts with courses fitting into a student schedule, counselors will contact the student during the summer to discuss the conflict and alter the student's schedule. It is very important that parents make sure that their family contact information is updated with the school so that counselors are able to notify students of any problems with their schedules in a timely manner.

DIGITAL RESOURCES FAMILY QUESTIONNAIRE

The New York State Education Department (NYSED) requires that districts send a digital resources questionnaire to parents and guardians. This information is meant to assist the state and districts in providing resources to students and families. NYSED asks that parents/guardians complete a questionnaire for each student in grades K-12. You can access the questionnaire by logging in to the Parent Portal. An instruction sheet is included in this month's newsletter.

PESTICIDE APPLICATION

New York State Education Law Section 409-H, effective July 1, 2001, requires all public and nonpublic elementary and secondary schools to provide written notification to all persons in parental relation, faculty and staff, regarding the potential use of pesticides periodically throughout the school year.

The Horseheads School District is required to maintain a registry of persons in parental relation, faculty and staff who wish to receive 48-hour prior written notification of certain pesticide applications. The following pesticide applications are **not** subject to prior notification requirements:

- A school remains unoccupied for a continuous 72 hours following an application
- Anti-microbial products
- Nonvolatile rodenticides in tamper resistant bait stations in areas inaccessible to children
- Nonvolatile insecticidal baits in tamper resistant bait stations in areas inaccessible to children
- Boric acid and di-sodium octaborate tetrahydrate
- The application of EPA designated biopesticides
- The application of EPA designated exempt materials under Title 40, Code of Federal Regulations (CFR) Part 152.25
- The use of aerosol products with a directed spray in containers of 18 fluid ounces or less when used to protect individuals from an imminent threat from stinging and biting insects, including venomous spiders, bees, wasps and hornets. In the event of an emergency application necessary to protect against an imminent threat to human health, a good-faith effort will be made to supply written notification to those on the 48-hour prior notification registry.

IMPORTANT INFORMATION FOR PARENTS OF NEXT YEAR'S SENIORS: MENINGOCOCCAL VACCINE(S) REQUIRED BY START OF SCHOOL YEAR IN SEPTEMBER

Beginning September 1, 2016, all students entering 7th and 12th grades in New York State must be fully vaccinated against meningococcal disease in order to attend school. **Students who are not up-to-date will not be allowed to attend school until they are vaccinated.***

Parents, please note Before school this September:

- Your 12th-grader must have received two doses of the meningococcal vaccine unless he/she received the first dose after turning 16. Most students entering 12th grade got their first dose when they were younger and are now due for their second dose, or booster. This booster is needed because protection from the vaccine decreases over time.
- If your child had one or two doses of the meningococcal vaccine prior to his/her 16th birthday, he/she must have a second dose in order to begin school in September.*

It's best to check with your doctor to see whether or not your child needs the vaccine. The vaccine may be given by your primary provider or the Chemung County Health Department. For information on how to get the vaccine at the Health Department and particular insurance coverage, call 737-2028.

About the Vaccine:

- It's not a new vaccine; it has been recommended for a decade.
- What's new is that the vaccine will be **required** for school entry as of September 1, 2016.
- Most parents already choose to vaccinate their children.

About Meningococcal Disease:

- It causes bacterial meningitis and other serious diseases.
- Teens and young adults are at greater risk.
- It comes on quickly and without warning.
- Its symptoms are similar to the flu.
- Every case of this disease can result in death or long-term disability.

*Public Health Law requires that all students meet immunization requirements. Students transferring within New York State have 14 calendar days to submit required immunizations. Students transferring from out of state or out of country have 30 days to submit required immunizations.
