Dear Parents and Guardians:

As you know, six of our seven schools remain in the state-designated orange zone. New state guidance allows orange zone schools to reopen to hybrid learning as long as state requirements for testing are met. We'd like to update all parents and guardians on a variety of topics. Parents/guardians of students in grades PreK-4 were sent an additional update earlier today.

Grades 5-12

As we prepare to return to hybrid instruction at Center Street, Gardner Road, and Ridge Road on December 14, we also plan for the reopening of our grades 5-12 schools to hybrid instruction. Specific dates for Intermediate, Middle, and High School students to return to hybrid instruction are not yet set, but our plan is for the schools to reopen to hybrid instruction sometime in January with testing requirements in place.

State designations for schools

Even as we plan for reopening, we must also be very mindful of the fact that our schools' status remains at the discretion of the governor. If at any time he changes the zone designation in our area, our plans will have to change to reflect any new changes. We ask that parents and guardians keep this in mind and continue to read and listen to our district updates sent via auto-email and auto-call.

Safety protocols

We also remind parents and guardians of our safety protocols. We have revised the information on returning to school based on guidance from the state. Screening survey

As schools reopen in phases to hybrid learning, we will once again require parents/guardians to complete the screening survey on the days their children attend school. Our reminder emails for grades PreK-4 hybrid learning students are currently being sent. These emails for grades 5-12 will resume prior to these schools' reopening dates for hybrid instruction. If you cannot complete the survey online, we ask that you contact your school that day. Most importantly, if a child has any symptoms, please keep the child home and contact the school nurse for guidance and follow-up.

As we move toward the holiday and throughout the school break, we ask that you continue safety practices of avoiding gatherings and/or non-essential outings/contacts, wearing masks, maintaining safe distancing, and thorough and frequent hand washing. This way we all work together to keep our students, staff, and community safe.
