

Horseheads Central School District 2024 Spring Sports Season – Athletic Placement Process (APP)

What is the Athletic Placement Process?

The APP process is to ensure that student-athletes get the opportunity to participate at the appropriate level that safely benefits the student, the team members involved, and the overall program. In an effort to properly place students where they can maximize the benefits, the district has chosen to participate in the athletic placement process (APP). program that allows students in grades 7-8 to play up (Modified to JV/Varsity Level) and students in grades 9-12 to play down (JV/Varsity to Modified) if all requirements of the evaluation process are completed successfully.

Is the Athletic Placement Process required by school districts?

No. NYSED created guidelines for school districts to follow if they choose to participate. Horseheads Central School District is currently choosing to participate in the APP process using NYSED guidance.

How does the Process Start for my Student?

The process starts with only the *Varsity head coach providing a recommendation* to the athletic director. Any other person within the program does not have the authority to make such recommendations including parents. The athletic director then considers all recommendations and makes final approval for head coaches to invite students to voluntarily participate in the program by communicating the parents.

Why would my child be recommended to participate in the APP process?

Your child would be recommended if the Varsity Head Coach has observed your child participating in the specific sport and feels they are exceptional skill wise. Coaches also take into consideration physical maturity level, size, social and emotional readiness.

Does my child have to participate in the process?

This program is **optional/voluntary** and is only intended for students with the appropriate physical maturity level, size, social and emotional readiness, and whose athletic abilities are outside of those of their age-related peers. Students who choose to participate will be put through the evaluation process.

What happens if they successfully complete the APP?

Upon successful completion, the student is granted a tryout, not automatically placed on a team. During the tryout, if it is not determined that the student will compete in at least 50% of the games, the student is sent back down to the age-specific level.

How and why will the district evaluate recommended students?

Using the guidelines from the NYSED (New York State Education Department), the district will evaluate the maturity level of each student as well as their overall fitness. Other aspects included in the evaluation are the social and emotional readiness of each student.

Area of Evaluation	The "Why"?	Methods Used:
Maturity	This evaluation is to determine if the child has reached a stage of physical development that will lessen the likelihood of a student being injured by participating in the level and sport desired.	Physical Evaluation Tanner Scale Height/Weight
Fitness	Each student must meet the requirements, by age, for 4 out of 5 physical fitness components taken from the President's Physical Fitness Test. This shows they have the physical ability to compete at the desired level.	President's Physical Fitness Test
Social and Emotional Readiness	Playing a sport with non-peers can be a challenging situation and an environment that goes against the expected benefits or eliminates the benefits all together. The social and emotional readiness evaluation helps to ensure a student can withstand the longer seasons, the peer interactions, and any other situations they may not encounter at their same-age level. Why does the district make the final determination?

As a school district, the safety of our students is a top priority. We take every recommendation, evaluation, and decision seriously as they are all meaningful and impactful to a student's safety. By completing the thorough evaluation, the district has final determination in passing/failing the APP process. This is to ensure that to our fullest extent, the district protects the safety of the student. This is also per the NYSED guidelines.

Who is responsible for the completion of the program paperwork?

The paperwork required to begin this process starts with the Varsity head coaches and the Athletic Director. After proper communication, the parents are responsible for giving permission for their child to participate in the program and for returning the paperwork by the deadline. Once returned, all paperwork is used for recording and reporting results to the appropriate stakeholders.

Note: It is up to the student's parent/guardian to pick up the APP packet for their student at the AD's Office, review it with their student, and provide required permissions for the APP process to move forward. Completed permission forms must be delivered to the middle school nurse's office by the deadline established for the season. Failure to meet this permission form submittal deadline will end the APP consideration for the student.
