Horseheads Central School District **Capital Project Referendum** Tuesday, December 7, 2021

Dear Community Members:

On Tuesday, December 7, the Horseheads Board of Education will ask district residents to vote on the next major district-wide capital improvement plan called *Horseheads 2030: Continuing Our Build*.

Voters approved the first project of our plan in October 2017 with 82% voting yes. That project has resulted in major improvements at the High School and Middle/Intermediate complex, with some improvements at the elementary schools. This second of three projects would continue the build, upgrading more areas to current standards.

This project brings more focus to our elementary schools, adding classrooms, renovating cafeterias and gyms, and improving the environment for our elementary students. There would also be additional work at the High School, including additional classroom renovations, a multi-purpose gym facility, and the addition of locker rooms, physical therapy spaces, and music storage at the new district stadium. There will be gym/locker room improvements, roofing, and parking lot redesign at the Middle/Intermediate schools. More information on the proposed project is on the pages of this newsletter.

This project would also enable the district to regulate the temperatures in our classrooms/buildings through the continued installation and upgrade of heating/ventilating and cooling systems. Nearly all stores, businesses, and government buildings provide temperature controlled spaces, with air conditioning as the weather determines. We believe our schools should too so that our students can be in an environment that is more conducive to learning. The upgraded mechanical systems of this project would address both heating and cooling in our schools.

Like the first project, this project would utilize the maximum state aid available to the district so that the impact to our local taxpayer would be as minimal as possible. We know that taxes fund state aid, but we also are aware that these state funds would go to school districts elsewhere in the state if we do not secure them for our district.

We are proud that our first project is coming in within budget, and since the project began, the district's full value tax rate has decreased. This first project has brought some great improvements to our schools, including our new multi-purpose stadium, where football and soccer games have brought our community together and increased school spirit. Use of this facility will include spring sports and other school and

community events and performances.

The current and proposed improvements will enable us to provide the best educational atmosphere for our children. It is not just our mission to educate our children; it is our responsibility. Horseheads 2030: Continuing Our Build

The project to be offered to voters on December 7 includes upgrades and improvements to district schools and totals \$122,254,993. It is the second of a three-phase project to bring needed improvements to all district facilities.

In October of 2017, voters approved a \$94 million capital improvement project to begin updating our

district schools and facilities. We called the project *Horseheads 2030: Building Our Future Now* because the students entering PreK at the time would be graduating in 2030. The first project, which focused on spaces at the High School and Middle/Intermediate complex and operational systems at the elementary schools, is nearing completion.

This new project would bring additions and improvements to Big Flats, Gardner Road, and Ridge Road elementary schools as the district phases out the use of Center Street for students. Through this project, the district would redraw attendance zones so that enrollment across elementary schools is more balanced, and improve boundary lines so that students attend the elementary school closest to their home when possible.

As one of the district's oldest buildings, Center Street would require extensive mitigation work to continue to be up to state standards for students to be in the building. The school is safe in its current state, but once any part of it goes under construction, full asbestos and lead abatement must occur. The cost for this work would require a significant local taxpayer share even with state funding. Center Street would be phased out as a student-use building with as minimal impact on students as possible and transitioned to an adult-use building.

This project also includes the renovation of gymnasiums across the district and the addition of locker rooms, physical therapy space, and music storage at the multi-purpose stadium at the High School. Additionally, this project would address the environmental climate at all schools, preparing them for updated heating, ventilating, and cooling controls.

The scope of work for our capital projects was developed through planning and study with the assistance of the district's architect, construction manager, and financial advisors. The district also used the state-required Building Condition Survey and worked with students, staff, and community members to develop the scope of the district's capital projects in 2016.

Elementary Schools

Ridge Road, Gardner Road, and Big Flats would see cafeteria and kitchen renovations, gymnasium/ stage renovations/additions, and classroom additions. The additions would allow the district to redraw and improve attendance zones as we phase out the use of Center Street for students. The libraries at Big Flats and Ridge Road would also be relocated and renovated, and the library at Gardner Road would be renovated. HVAC upgrades and replacements, playground improvements, and parking lot and sidewalk improvements would take place at all three schools.

Middle/Intermediate Schools

The Middle/Intermediate complex on Sing Sing Road would see gymnasium and locker room renovations, roof replacement, upgrades and replacements for HVAC, and a redesign of the main parking lot for better traffic flow.

High School

At the High School, there would be renovations of several classrooms adjacent to a new multi-purpose physical education and athletics facility in the south wing. This space would include a large gym with several partitioned physical education spaces, indoor track, wrestling room, flexible training/exercise space, and weight room. The High School complex would also see upgrades and replacements for HVAC and site improvements including sidewalks, traffic flow, and parking lots.

Multi-Purpose Stadium

The multi-purpose stadium at the High School would be completed with locker rooms, physical therapy/trainer spaces, and a music storage room adjacent to the main entrance.

Q&A 0: Why is this project needed?

A: Capital improvement projects like this one improve the educational environment for our current and future students. This project is an investment in our community, continuing the improvements to our district. A quality school district with up to date facilities



helps to maintain property values and brings families and businesses to our community.

The first project included a portion of the upgrades and improvements identified by the district in the 2015 Building Condition Survey, a state-required document surveying the district's infrastructure. The main focus of the first project was the High School and Middle/Intermediate School, with basic operational and safety systems in our elementary schools.


This project would bring improvements and upgrades to elementary school cafeterias, kitchens, and gymnasiums. It will add classrooms to the three elementary schools to allow the district to redraw and improve attendance zones. The project also includes additional improvements at the High School and Middle/Intermediate school complex.

Q: If approved, when would the project begin and when would it be completed?

A: If the project is approved, the district would work with its architect and financial advisor to finalize the design plans to be submitted to the New York State Education Department (NYSED) for approval. Once the state approves the plans, the project will be publicly bid. We expect some bids to be awarded as early as the spring of 2023, with phased construction beginning in the summer of 2023. We anticipate the scope of this second major project to be completed Fall 2026 to Summer 2027.






Absentee Ballots

Registered voters who cannot get to the polls on December 7 due to illness or travel may vote by using an absentee ballot. Current rules allow any voter who is at risk of contracting or spreading a communicable disease like COVID-19 to request an absentee ballot.

Applications for absentee ballots are available in the district's Business Office, 143 Hibbard Road, Horseheads, from 8 a.m. to 3:30 p.m. up to and including December 6.

Completed ballots must be returned to the Business Office, 143 Hibbard Road, Horseheads, no later than 5 p.m. December 7.


The district mails absentee ballots to voters listed as "permanently disabled" by the Chemung County Board of Elections.



How would the project be funded?

The project would be financed with 15-year bonds, which will be paid for primarily with New York State building aid. Additional funds would come from existing district resources and money from the district's capital reserve to minimize the local share.

The district's financial advisors have been conservative in estimating interest rates and local share. Please note that the district estimated a small increase in the tax rate for the project approved in 2017; however, the tax rate has actually decreased since the project began due to assessment growth in our community and careful planning by the district regarding tax levy.

State Building Aid

New York State offers building aid to school districts on eligible building projects. The state uses a complex formula to determine aid, using a building's maximum cost allowance as set by the state. The district, architect, and financial advisors have worked to develop this project, maximizing state aid and minimizing local impact.

The district's current state building aid ratio is 82.1%. This means the district will receive 82.1% of eligible costs as state aid to fund this project over 15 years.

Existing District Resources

The district budgets \$1 million per year for small capital projects. The plan is to allocate these funds to this larger capital project each year for fifteen years for a total of \$15,000,000.



Capital Reserve

The capital reserve is a savings account the district can use to save money toward large scale capital projects over time. In May 2017, district voters approved an increase to an existing Capital Reserve limit. In addition, a new capital reserve was approved by voters in May 2019. The district would use \$10,000,000 from these reserves for this project.

Local Property Tax

The district's financial advisors have arrived at a conservative estimate of a 6.34% increase in the tax levy to fund this project over 15 years.

For a home with a full value of \$100,000 without a STAR exemption, this would amount to an increase of *\$109.90, or 30 cents per day*, phased in over a four-year period beginning in 2023. If the homeowner has the **Basic STAR exemption**, the estimated increase would be **\$76.93**; for those with the **Enhanced STAR exemption**, the increase would be **\$32.20**.

District Tax Rate on Full Value Assessment

The district's current tax rate is \$17.32 per thousand on full value assessment. Last year's tax rate was \$18.00 per thousand. Ten years ago, the tax rate was \$18.26 per thousand. This decrease is due to good financial stewardship and growth in property values across the district.

Full value assessment means a property's value is assessed at 100% of market value. The district is made up of all or parts of seven municipalities. Each municipality determines its own level of assessment. Some maintain assessments at full market value, and some do not.

Because each municipality within a school district has its own level of assessment, the assessments must be equalized to full market value prior to determining the tax rate for each municipality. The district does this by applying equalization rates provided by the state's Department of Taxation and Finance. If your tax bill shows a different tax rate than \$17.32, this means that your municipality does not assess at full value.

Q: How has the tax rate changed since the approval of the first project in 2017?

A: The current tax rate is \$17.32 per thousand of a home's full value assessment. In 2017, when the first project was approved by voters, the tax rate per thousand of full assessed value was \$17.54, so the full value tax rate has decreased -1.25% since the



project was approved. The current year tax rate is a decrease of -3.78% from last year (\$18.00 per thousand of full value assessment). Overall, the district was able to manage its yearly budgets since 2017 and complete a \$94 million capital project during the same time while lowering the tax rate.

Q: Why weren't the stadium locker rooms and music storage built in the first project?

A: The entire stadium complex could not be completed in the first project without a significant local burden on the taxpayer.

Not all capital expenditures are state aidable. Additionally, the state sets the aidable amount a district can spend on construction during a specific project, based on a complex formula. Any unaidable work and any amount beyond the aidable amount must be paid for at the local level, without state aid. The district developed a plan to minimize the impact on the local tax base by distributing unaidable construction throughout the district's capital projects. It would not

have been fiscally responsible to have completed the entire stadium complex in the first project.

So far this year, the stadium has held football games, soccer games, marching ensemble performances, the High School pep rally, opening day for district staff, and graduation for the Class of 2021. That class was the first group to be at the stadium in June 2021.

Q: What is meant by climate control in school buildings?

A: Climate control systems control the heating and cooling of buildings. This project would upgrade these systems at several schools so that we can provide an environment that is more conducive to learning, both on the hottest days and the coldest days of the school year.

Q: What is state aid?

A: New York State aid is the major source of funding the state provides school districts and municipalities. The funds come from taxes paid to the state by everyone in New York State. State building aid goes to districts across New York State with voter-approved capital projects. Horseheads district taxpayers pay into this statewide pool of money.

The district wishes to secure our share of these vital statewide building funds for our local community in order to continue the capital improvement which began district-wide with the first project that was approved by 82% of voters.



Q: What happens to Center Street in this

project?

A: C e n t e r Street is one of the district's oldest buildings. For it to continue to be up to state standards for students to be in a building, it would require extensive mitigation work.



The district's 2015 Building Condition Survey and consolidation study in 2014 identified Center Street as a building that should be considered for closure or adult use.

Like many buildings its age, Center Street contains asbestos and sealed lead paint. The school is safe in its current state, but once any part of it goes under construction, full asbestos and lead abatement must occur at separate times. The cost for this work is prohibitive even with state funding and would require a significant local share in order to make improvements for student use of the building in a reasonable amount of time.

The plan for Center Street would be to phase it out as a student-use building in order to have as minimal an impact on students as possible and transition it to an adult-use building.

The district would still maintain ownership of the Center Street building so that it can be used for appropriate adult use: district offices displaced by capital construction, facilities offices and maintenance work areas that will need to be relocated once its current building is converted to the main parking area for high school activities, and a potential community-centered location for various programs (senior center, youth bureau, etc.).
