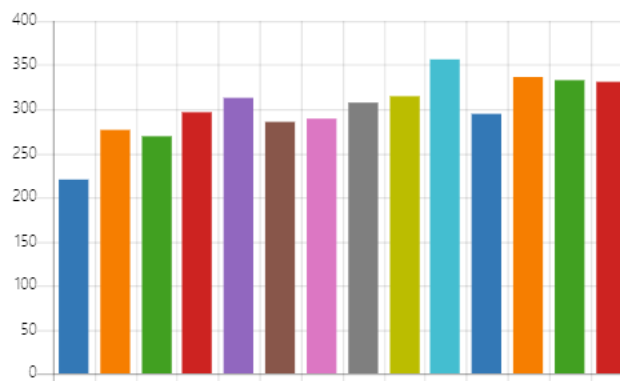

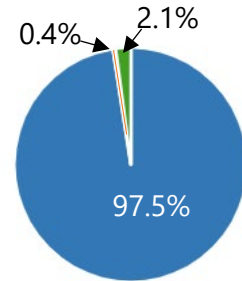

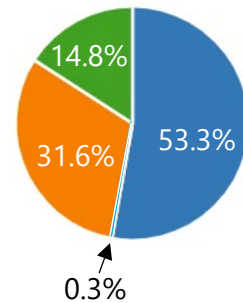
**For the 2020-21 school year, what is your preference for your child(ren)'s education in 2020-21?**

- Home schooling (parent provides non-district curriculum and submits Individual Home Instruction Plan) 53



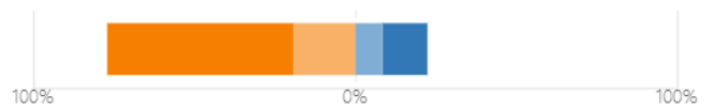

- No preference indicated 8



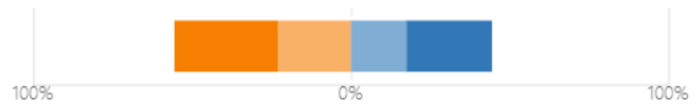
**If the district were to be able to provide parents a choice for instruction in the 2020-21 school year, how likely would you participate in the following: 100% in-person instruction**

- Very unlikely 14.1%



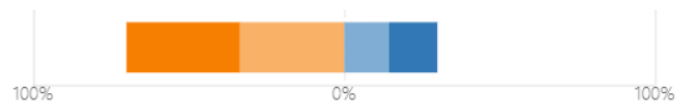
**If the district were to be able to provide parents a choice for instruction in the 2020-21 school year, how likely would you participate in the following: 100% at-home remote/online instruction**

Very unlikely	27.0%



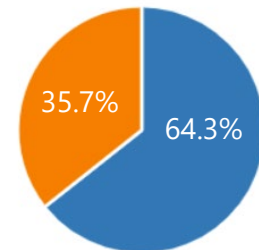
